We use NRA Service Rifle Rules with the exception of allowing up to 3 sighters to start the match. A copy of the Service Rifle Rules can be obtained from the NRA or online at http://competitions.nra.org/documents/pdf/compete/RuleBooks/HPR/hpr-book.pdf Match scoring is done by Team. **Teams with less than three shooters will not be awarded any Team Points.**

Scores will be sent to the **NRA** at the end of the season, and all competitors who pay the league fee and fire 3 or more matches will receive a league T-shirt. Shirts will be given to the Team Captains at our annual awards banquet.

You MUST send registration/match fees to the team captain, in advance of each match to reserve a firing position. Reservations are limited to two relays. If additional firing points are available on later relays, you can fire again, but only at the time the relay is called to the line. Checks in payment of league and match fees should be made **payable to the captain** of the hosting team.

Please fill out all information CLEARLY and completely! Make sure you have your NRA number and T-shirt size indicated, especially on the first match you shoot this year.

Please take time to help new competitors fill out score sheets properly. Help your Team Captain run the match if it is being hosted by your club.

If you are firing ahead the first match goes for the match date, second goes to the next match or the third, whatever the case might be.

RANGE AND FIREARM SAFETY

You must have your rifle aimed at the backstop while closing the bolt and finger off the trigger until sights are engaged on the target. We simply cannot take any chance of an accidental discharge sending a projectile out of any of our ranges. All rifles will have Empty Chamber Indicators (ECI) inserted at ALL times, except during preparation periods or actually firing. Remember, Safety First, Last and Always.

Postal scores will be used in computing individual averages and sent to the NRA for classification use. Only two Postal Scores are allowed for each competitor.

Matches will be shot in the conventional order, with (3) sighters allowed in the match. (50) shots will be fired for record.

1) Offhand	10 rounds	10 minutes	SR-1 reduced target
2) Rapid Sitting	10 rounds	60 seconds	SR-1 reduced target
3) Rapid Prone	10 rounds	70 seconds	SR-21 reduced target
4) Slow Prone	20 rounds	20 minutes	MR-31 reduced target

Match fees are \$10.00 per match.

NRA Fee - All scores will be sent to the NRA. This necessitates a one-time payment of \$15.00 at your first match. The \$1.00 will cover the NRA recording fee and part of the cost of a T-shirt – all competitors firing (3) or more matches in the season will receive a T-shirt with the league logo.

Relays begin at 9:00 A.M., 10:30 A.M., 12:00 P.M., and 1:30 P.M. Firing points may be reserved by contacting the respective Team Captain and sending money. Make checks out to the Team Captain you are registering with. You must check in at the range (15) minutes prior to the scheduled start of your relay.

Northeast Wisconsin High Power League 2022 Postal Match Procedure

The NEWHP League consists of scheduled Matches. Postal Scores are allowed for the 2022 season.

Competitors can shoot up to five matches for 2022 at the regularly scheduled face-to-face matches AND/OR shoot up to two 'postal matches' in whatever combination.

All matches are to be shot in the conventional order at 100 yards.

Up to (3) sighters are allowed to begin the match. Sighters are to be pasted before record shots commence. Then (50) shots will be fired for record. (Shooting ahead or behind at a scheduled Match is not considered a Postal Match)

- 1) Offhand 10 rounds 10 minutes SR-1 reduced target
- 2) Rapid Sitting 10 rounds 60 seconds SR-1 reduced target
- 3) Rapid Prone 10 rounds 70 seconds SR-21 reduced target
- 4) Slow Prone 20 rounds 20 minutes MR-31 reduced target

For Postal Scores - Match fees are \$10.00 per match.

NRA fees will be collected this year and scores will be submitted to NRA for classification. Please pay your NRA fee at either the first match you shoot or to the designated contact who you purchase postal match targets from.

Postal Match Procedure:

Designated contacts have been established to supply and collect targets for the Postal Matches – the contacts are listed below.

Competitors will have the option of shooting up to five matches for 2022 at the remaining scheduled matches AND/OR shooting up to two postal matches in whatever combination. **To qualify for Team Points, Postal scores must be submitted with 14 days of the scheduled Match to which the scores will be applied.**

Competitors wishing to participate in the postal matches must:

- 1) Coordinate with a Designated Contact to purchase targets. The targets will be labeled and these targets must be used to shoot the match. Match fees are \$10 per match.
- 2) The competitor can then shoot the match at the venue of his or her choice following the format described above.
- 3) Postal matches must consist of at least two competitors.
- 4) The competitor then should score the targets using a standard NEWHP score sheet.
- 5) The competitor needs to coordinate with the same Designated Contact to turn-in the score sheet(s) and targets. All score sheets and targets need to be turned-in to the designated contacts by **September 30**, 2022.
- 6) Finally, the Designated Contact will be asked to check/verify score, sign the score sheet as scorer, and submit the score sheets to Jeff Verhaeghe by **October 10, 2022**.

Take U.S. Highway 41-141 North of Green Bay to Brown County Trunk "B" (Exit 176, Sunset Beach Rd. Suamico Exit, [New Zoo], etc.). This is approximately five (5) miles North of Tower Drive, (Interstate 43.) Exit onto County Trunk "B" and head West on "B" (left at the stop sign and pass under Hwy 41-141). You will come to a four-way stop at the intersection of County Trunks "B" and "HS", also known as the intersection of Sunset Beach [or School] Rd. and Velp Ave. Continue West on "B" for 9/10 mile, just past the Suamico Elementary School (on your left), and turn left onto Riverside Drive. The turn is before you cross the railroad tracks. Proceed South on Riverside Dr. for 3/10 mile to the intersection with St. Pat's Drive. (It comes from the right, only). Turn right onto St. Pat's Dr. (West) and proceed, crossing the tracks, for 9/10 mile. The range is in the woods, on the right, just before the road curves sharply left. For those with GPS, our gate is located at N4438.062" W8805.314"
